

2023-2024 SHOPPING POLICIES Child Care Centers & Family Childcare Providers

Crayons to Computers was founded in 1997, and today partners with more than 450 qualifying schools serving Preschool through Grade 12 students in 16 counties throughout Southwest Ohio, Northern Kentucky, and Southeastern Indiana. As a nonprofit organization funded largely through donations, we aim to bridge the gap, helping teachers to provide their students in need with the tools to succeed in school. We offer a variety of materials that support learning, including basic supplies, educational activities, and enrichment items. Since inception, Crayons to Computers has distributed more than \$191 million worth of free educational materials.

WHAT PRESCHOOL PROGRAMS QUALIFY TO SHOP AT CRAYONS TO COMPUTERS?

Preschool Programs must complete an application and be accepted into the program in order to qualify to shop. To be considered programs must:

- Serve primarily preschool-aged children (ages 3-5);
- Be located within the 16 counties currently served by Crayons to Computers
- Accept state assistance from families who qualify to help them pay for childcare and serve a majority of children receiving state assistance;
- Be in operation for at least 1 year;
- Be a Child Care Center or Family Child Care Program that:
 - Currently holds a quality rating with Ohio's Step Up to Quality, Kentucky's All STARS program, or Indiana's Paths to QUALITY OR
 - o Is recommended by 4C for Children or EC Learn and actively working toward a quality rating or improving their quality rating.

WHICH PRESCHOOL PROGRAM PERSONNEL QUALIFY TO SHOP AT CRAYONS TO COMPUTERS?

All shoppers must be employees of their program. The number of shoppers is based on your type of program:

- Family Childcare Programs: TWO designated shoppers from your program.
- Child Care Center: Number of shoppers is determined by how many active classrooms you have plus one administrative person. For example, if you have 4 active classrooms, you may designate 5 shoppers from your program.
 - We appreciate you only adding staff that will participate in the opportunity. Centers do not have to add their full capacity.
 - o Shoppers must shop under their name only. Shopping visits cannot be transferred to other active shoppers. Staff replacements can be made in the case of staff turnover.

A list of each program's eligible shoppers must be submitted by a Director or Administrator by July 31, 2023 in order to be able to shop during opening week. Changes and updates through the year should be made by the same contact. Eligible shopper lists and updates should be emailed to Caitlin Philpott, cphilpott@crayons2computers.org.

Allow one business day for updates to be completed and take effect.

TERMS OF AGREEMENT

By participating with Crayons to Computers you commit to utilizing all items for the benefit of students and families in your school community or for your own purposes within the school. The resale of items received from Crayons to Computers is strictly prohibited.

WHAT IS THE ACCESS FEE PAYMENT PROCESS?

NOTE: There is NO access fee for all our approved Providers for the 2023-2024 school year. Please consider thanking First Financial Bank for the third consecutive year of generously covering all our early childcare providers. CAN MY PROGRAM BE TAKEN OFF THE CRAYONS TO COMPUTERS ELIGIBLE LIST?

Any program who has not shopped for 1 whole school year will be taken off the eligible list and will have to reapply if interested in shopping again.

Serving quality childcare programs is a priority for Crayons to Computers. Any program who does not achieve a quality rating or loses their quality rating will be taken off the eligible list and will have to reapply. This applies to all eligible preschool programs, regardless of when you were accepted.

Shoppers represent their programs and are asked to agree to our Terms of Use policy below. Shoppers or programs found to be misusing supplies or not following posted limits may be taken off the eligibility list.

WHEN CAN TEACHERS SHOP AT CRAYONS TO COMPUTERS?

Teacher Resource Center Dates of Operation: August 8, 2023 - May 16, 2024 Please note the Resource Center will be closed on the following dates:

- September 4, 2023 Labor Day
- November 22 & November 23, 2023 Thanksgiving Break
- December 18, 2023 January 2, 2024 Holiday Break

Teacher Resource Center Hours:

- Tuesday Thursday, 2:30 p.m. 6:30 p.m.
- The second and fourth Saturday of each month, 9:00 a.m. 1:00 p.m. Extended hours may apply in August.
- Note: Teachers should check in at least 30 minutes before closing to ensure enough time to shop.

<u>*Please always</u> check our website (<u>http://www.crayons2computers.org/</u>) to confirm shopping days, as changes may occur during the year. Also note, while Crayons to Computers' business/office hours are 9 a.m. - 5 p.m., <u>the Teacher Resource Center opens at 2:30 p.m.</u>

HOW MANY TIMES ARE TEACHERS ABLE TO SHOP AT CRAYONS TO COMPUTERS?

- All teachers are welcome to shop with Crayons to Computers <u>up to 10 times per school year</u> regardless of the channel (in-store and/or online ordering).
- There are no longer assigned shopping times or weeks. Shoppers can come anytime the store is open.
- Only one shop per teacher will be allowed in August. Shopping online counts as one shop. Shoppers can choose whether to shop online or in-store in August.
- Shoppers may not send other people, even eligible shoppers, on their behalf to utilize instore shopping visits. We do allow online order pickup by alternate people.

I'M ELIGIBLE, HOW DO I SHOP?

When teachers arrive to shop at Crayons to Computers, a staff member or volunteer will greet, check-in, and orient you to the Teacher Resource Center.

What should I bring?

- Teachers must provide a school ID with a photo or a driver's license to check-in.
- Mask requirements will reflect current CDC and/or State of Ohio guidelines.
- We provide boxes for shoppers but cannot always guarantee we will have enough stock. Please consider bringing your own boxes or reusable bags.

Where do I park?

Parking is available on the east side of the building closest to the Teacher Resource Center entrance. If this parking lot is full, there is an overflow lot available on the west side of the building. There is also limited on-street parking. Always enter through the Teacher Resource Center entrance on the east side of the building. We appreciate your following all parking signs and only parking in legal parking spaces. Please do not park in front of our loading docks or block any other cars in our lots. Further:

- Please do not park in any neighboring businesses' parking lot.
- Please do not leave purses or any other valuables in your car while you shop.
- Crayons to Computers is not responsible for lost or stolen articles.

Can I bring someone along when I shop?

Due to health and safety precautions, size of our shopping space, and out of consideration for your fellow shoppers, please be conscientious if you must bring shopping companions (including small children) to the Teacher Resource Center. Children & guests should stay with the shopper at all times and are not eligible to shop themselves.

Companions for visually impaired or those in need of medically comparable assistance are welcome. Contact Caitlin Philpott, at cphilpott@crayons2computers.org with questions.

• We are a mask-optional facility, so please take this into consideration with any shopping companion who accompanies you.

Anything else I should know?

- Please plan to return your shopping cart into the Teacher Resource Center after unloading!
- When you check out, a volunteer or staff person may share the total value of your trip. Keep
 in mind all supplies received at Crayons to Computers are FREE for your use at school with
 your students and <u>NOT</u> for personal benefit or resale. (See Terms of Agreement above.)
- The average teacher receives more than \$500 worth of supplies each shopping trip.
 - o When dictated by a grant, on extreme occasions, some items may have restrictions.
 - We do our best to ensure items will last through the day, but that is not always possible due to the nature of donations.
 - You are invited to speak with a staff person for any questions regarding item availability or your individual needs.
- Item limits allow us to best serve all shoppers. Please respect item limits. Exceptions must be cleared with a staff member <u>prior</u> to checkout. Volunteers may check items and counts to help ensure inventory accuracy.
- Shoppers may only check in under their own name and will not be able to shop on behalf of another teacher.
 - We have online ordering for pickup for teachers that are unable to make it down for a shop or who do not feel comfortable coming to shop in person.
 - o Online orders are able to be picked up by alternate people.
- Shoppers who accompany others but are not shopping themselves are not able to add items to their shop on a previous date.
- Crayons occasionally has furniture that may require additional coordination for pickup. In respect for other shoppers and our space, we require that furniture be picked-up within one week of being tagged or it will become available to other shoppers.
- We reserve the right to share any shopping information with program administrator(s).

WHAT HAPPENS IN CASE OF INCLEMENT WEATHER?

In the event of inclement weather, Crayons to Computers will decide whether to close the Teacher Resource Center by 12:00 p.m. You will find this information listed on our website, Facebook, and on WCPO Channel 9 and WKRC Local 12 school/business closings list.
